# information to consider prior to nominating to the Board

It is recommended that nominees for a Board position review the role description for the Board of Directors - downloaded from joy.org.au

Board members are required to attend a minimum number of Board meetings, as outlined in the role description. The Board normally meets from 6pm on the third Thursday of each month. In some cases this is moved to the fourth Thursday of each month.

The nomination form must be completed and sent to the Secretary prior to the close of nominations. This can be provided via email or by post.

The candidate statement (250 words maximum) must be provided via email, to the Secretary, at secretary@joy.org.au prior to the close of nominations.

Candidate statements will be sent to all members to provide assistance in choosing whom to vote for.

#### voting process

If more than four (4) candidates nominate, a vote will take place by a formal ballot voting process. Eligible members who attend the Annual General Meeting can vote in person. Eligible members may also vote by nominating a proxy, but the proxy must be present at the Annual General Meeting to vote on your behalf.

The four (4) candidates who receive the highest number of votes will be elected.

## questions to consider

If you are considering nominating for a Board position, the following questions may assist you to make this decision:

- What are your general key competencies at Board level?
- What are the core business skills and knowledge that you would bring to this appointment?
- What are your desirable Board personal qualities and attributes?
- Do you know and understand Board governance, finance, confidentiality, risk and obligations?
- What do you foresee may be different in how you would need to behave as a Board member when interacting with other JOY volunteers?
- Do you understand the role of the Board and the role of governance of the organisation, as distinct from the operation of the station?
- Have you considered the meeting times and your ability to attend?
- Have you considered the time commitments with work/life balance?
- Would you have any perceived or actual conflicts of interest?
