# **Radiothon Prizes Terms and Conditions**

#### Who is eligible for a Key?

Anyone who registers as a New Member, renews their membership, or contributes \$50 AUD or more in a single transaction, is eligible to enter the draw to win a key.

Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. If a winner of a prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf.

JOY staff, volunteers, presenters and their families are not eligible to win a key or the major prizes.

## Is my Contribution Tax Deductible?

If you are receiving entries into our Key Draw, contributions are unfortunately not tax deductible. You may instead wish to donate during Radiothon, which is tax deductible, however these donations will not acquire entries into the key draw.

#### How do they get the key?

Entry into the draw is automatic, based on contributions and memberships received during the nominated period. Each eligible program will draw a winner from eligible entries received during their program.

Listeners that renew, signup as a new member, or contribute \$50 or more in a single transaction are eligible to enter the draw for a key.

The winner of the key will be drawn 10 minutes after the end of each program and announced on air during the next live program.

Keys are limited to 1 per person, you cannot win multiple keys.

## Can people enter multiple times to win a key?

Yes, if people want to donate \$50 or more in multiple shows they can, but they can **only win one key for the major draw.** Contributions of a value equal to multiples of \$50 in a single transaction are considered to be one entry, e.g. an \$80 contribution made in a single transaction is one entry, not two. Contributions that are equal value to more than one multiple of \$50 in a single transaction will be considered to be the number of entries that is equal to full multiples of \$50 in that transaction, e.g. a \$170 transaction is 3 entries not 4.

#### How is the key used?

On the evening of Friday 12<sup>th</sup> May 2023, we are inviting key winners to the Victorian Pride Centre where they will be given a key, they will then use their key to attempt to open 'the vault'. Five of the distributed keys will open the lock that corresponds to five separate major prizes. An official will be there to make sure the keys are fairly distributed.

#### JOY has no responsibility relating to the sponsors' delivery of their prize

Once the person has won the Vault draw JOY has no responsibility for what happens to the winner of the prizes if any accidents should occur whilst using the giveaways. The sponsors who donated the prizes will have a duty of care to ensure that the listeners don't have a negative experience.

## What happens if the person who wins a key can't attend

In this case a JOY representative will be allocated to represent that person, and will attempt to open the locks with the key on their behalf.

- 1. Information on how to enter the draw and the list of prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. The promoter is JOY MELBOURNE INC. (**JOY**) ABN 52 334 960 331, Level 1, 79-81 Fitzroy Street St Kilda VIC 3182. Radiothon commences 8am AEST Saturday 29th April and finishes at 11pm AEST Friday 5th May (**Promotion Period**).
- 3. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter, and the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the promoter to enter into a further agreement as evidence of consent to the minor entering this promotion. The parent/guardian is deemed to be the winner of the prize.
- 4. All prizes are to be collected from the promotor's Melbourne address, with winners bearing any cost associated with collection.
- 5. Entry to the prize draw is automatic for new memberships, renewed memberships, and contributions received during the promotion period.

9. Contribution Entries.

Contributions to JOY are automatically entered into the prize draw. Each \$50 contribution provides one ticket to prize draw. Contributions may be made across single or multiple transactions. For example, a contribution of \$149 provides 2 tickets to the prize draw. A contribution of \$151 provides 3 tickets to the prize draw.

- 10. The Business/Organisation prize draw will select a single winner from all entries during the Radiothon Party.
- 11. The prize draw process for Private memberships and contributions is as follows:
  - a. Entries are received when payment is cleared with JOY's merchant facility provider.
  - b. Several times each day, at the end of participating programs, all entries received since the previous draw will be aggregated and a provisional winner will be drawn from this aggregate.
