

# **TERMS & CONDITIONS**

## Sydney Mardi Gras Packages Giveaway

All information provided on how to enter the Competition and the prize available to the winner forms part of these Terms and Conditions.

By submitting an entry into the Competition, you agree to be bound by these Terms and Conditions. Only entries that comply with these Terms and Conditions will be considered valid and eligible to win a Prize.

#### **Competition period**

The Competition commences at 12:01am AEDT on 13/01/2025 and ends at 11.59pm AEST on 09/02/2025 (Competition Period).

#### Who can enter the competition

You are eligible to enter the Competition if you are:

- 1. currently residing in NSW, VIC, QLD, SA, NT, TAS or WA; and
- 2. aged 18 years or over; and
- 3. not an Ineligible Person

#### **Ineligible entrants**

An Ineligible Person means any director, paid employee, retailer, supplier, associated entity and agency associated with this Competition, or any immediate family member of any of those persons.

#### How to enter the competition
