



TERMS & CONDITIONS

JOY Media Radiothon 2025 Membership Competition Terms and Conditions.

1. Promoter

The promoter is JOY Media (JOY Melbourne Inc), ABN 52 334 960 331, Level 1, 79-81 Fitzroy St, St Kilda VIC 3182.

2. Competition Period

The daily show prize draws will take place between 7:00am AEST on 10 May 2025 and 11:00pm AEST on 16 May 2025.

3. Eligibility

Entry is open to all individuals aged 18 years or over who either:

- Take out or renew any type of JOY membership (excluding Under 18 membership) during the specified time/show as announced on air; and/or
- Engage with the show in the manner specified by the show's hosts (e.g., calling in, texting, or participating in an on-air activity).

4. Ineligible Entrants

The following individuals are not eligible to enter or win a daily show prize:

- Anyone under 18 years of age
- Employees, board members, and contractors of JOY Media (JOY Melbourne Inc)
- Volunteers (and their immediate family members) who are directly involved in the administration or draw of the individual prize
- Suppliers, associated companies, and agencies directly involved with the competition
- Anyone not residing in Australia

5. How to Enter

- For each show, the method of entry will be announced on air and may include taking out or renewing a JOY membership during the specified show or engaging with the show as directed (e.g., calling in, texting, or participating in an on-air activity).
- There is a limit of one entry per person per show prize, unless otherwise specified by the show's hosts.
- Entry into a daily show prize draw does not affect or exclude the entrant from entry into the major prize draw.

6. Prize Details

- There are 31 daily/show prizes to be won, to be awarded across JOY shows between 10 May and 16 May 2025.
- The full list of prizes is set out in Appendix A.
- Prizes are not transferable, exchangeable, or redeemable for cash unless otherwise stated.
- If any prize (or part of any prize) is unavailable, the Promoter reserves the right to substitute the prize (or that part of the prize) with a prize of equal value and/or specification, subject to any written directions from a regulatory authority.

7. Prize Draw

- Each daily/show prize winner will be selected at random or as otherwise specified by the show's hosts, from all eligible entries received during the relevant show or entry period.
- The draw for each prize will take place during the relevant show or as soon as practicable thereafter.

8. Winner Notification

- Winners will be notified on air, by phone, or by email as soon as practicable after the draw.
- Winners' first name, last initial, and suburb may be published on the JOY website (<https://joy.org.au/>) and/or JOY social media channels.
- An individual entrant can win a maximum of one prize during the competition period.
- If a winner is drawn and announced on air but is found to have already won a prize during the competition period, that prize will be forfeited.
- In such cases, a redraw will be conducted in accordance with the prize claim details below to select a new winner.

9. Prize Claim

- Winners must claim their prize within 14 days of notification.
- If the prize is unclaimed by 5:00pm AEST, 30 May 2025, JOY Media reserves the right to conduct a redraw at the same location and time 21 days after the original draw.
- Redraw winners will be notified via phone within two business days and in writing, and their first name, last initial, and suburb will be published on the JOY website.

10. General Conditions

- The Promoter reserves the right to verify the validity of entries and entrants (including an entrant's identity, age, and place of residence) and to disqualify any entrant who tampers with the entry process or submits an entry not in accordance with these terms and conditions.
- Incomplete, indecipherable, or illegible entries will be deemed invalid.
- If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- The Promoter's decision is final and no correspondence will be entered into.

- By entering, entrants consent to their name, likeness, image, and/or voice being used for promotional purposes in any media for an unlimited period without remuneration.

11. Ancillary Costs and Vouchers

Any ancillary costs associated with redeeming a prize are the responsibility of the winner. Any unused balance of a voucher will not be awarded as cash. Redemption of a voucher is subject to any terms and conditions of the issuer, including those specified on the voucher.

JOY Media, its agents, and sponsors are not liable for any loss, damage, or injury suffered (including but not limited to indirect or consequential loss) as a result of taking or using any prize, except for any liability which cannot be excluded by law.

JOY Media is not responsible for any delayed, lost, or misdirected mail or other communications, or for any technical failures affecting entry or notification.

13. Release and Indemnity

By accepting a prize, winners agree to release JOY Media, its agents, and sponsors from any claim, loss, damage, expense, cost, or charge sustained in connection with participation in the promotion and/or in use of the prize, to the fullest extent permitted by law.
